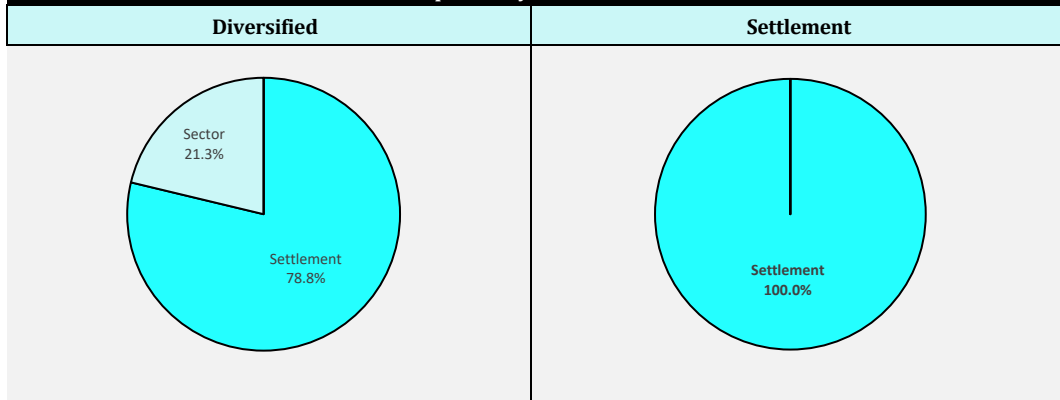

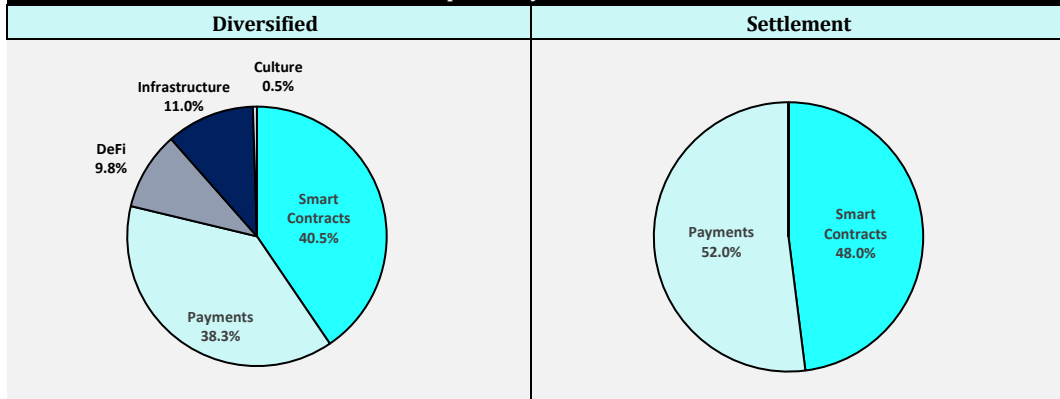

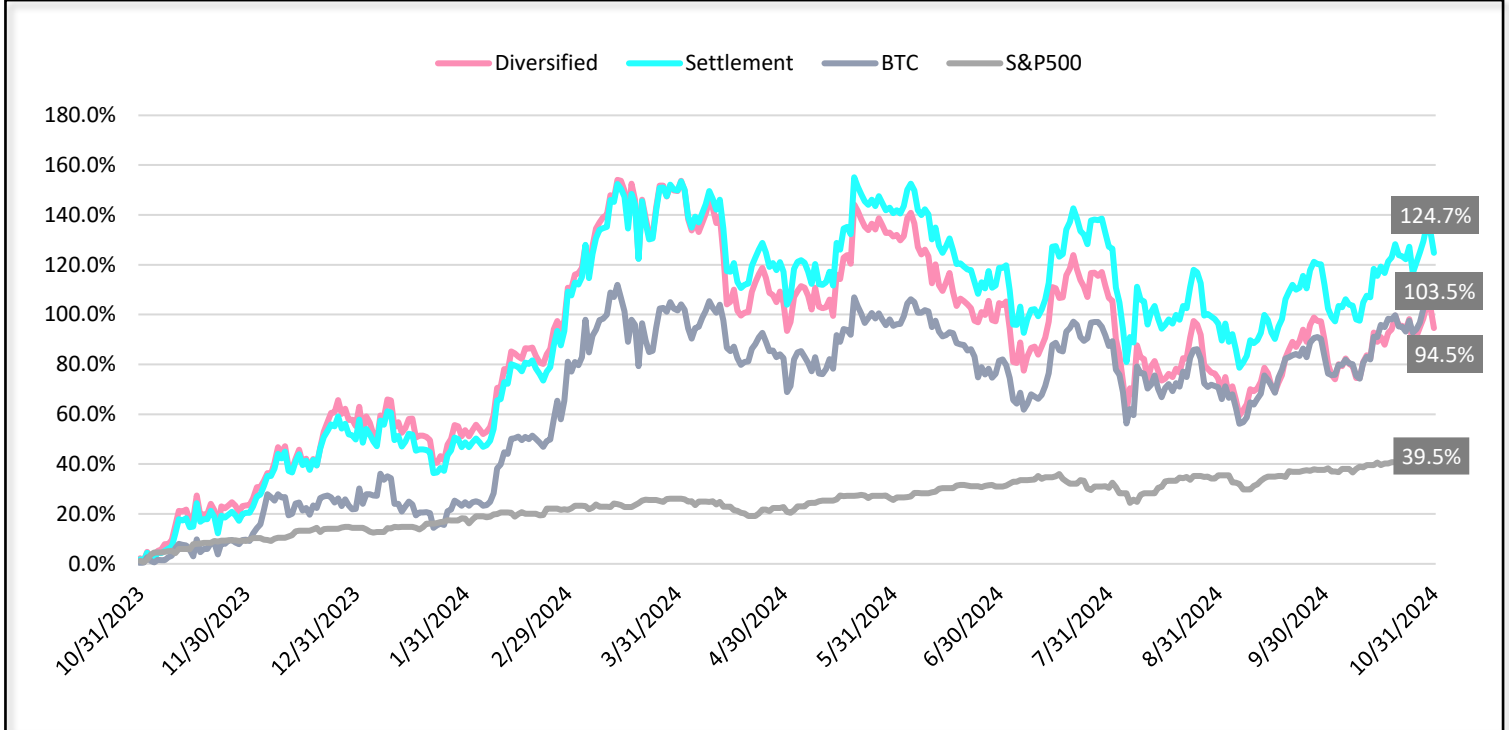

I earned my bachelor's degree in economics with a minor in finance from Tufts University and hold Series 7, 63, 65, and 79 licenses.

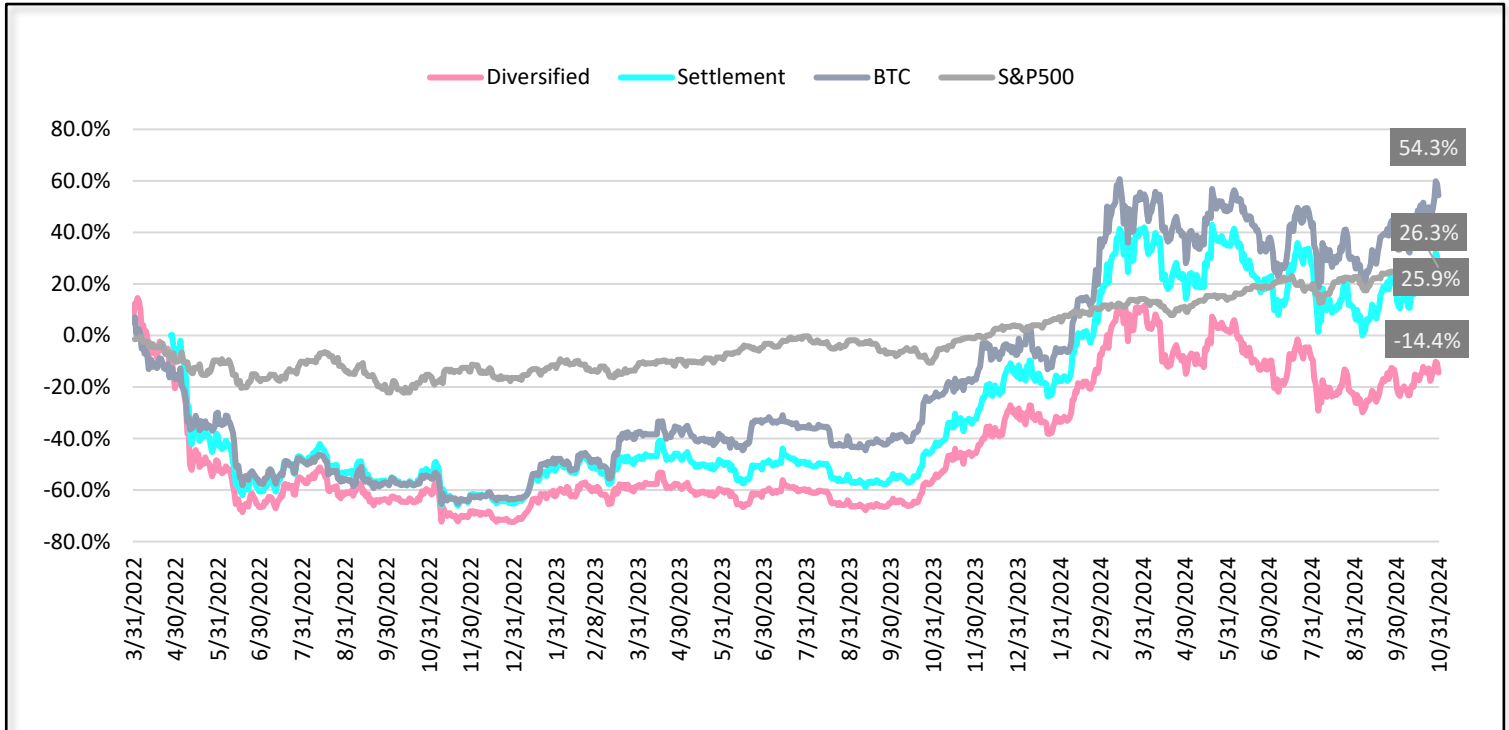
